Experience Scores: Please note that **the scores are based on experience from JCAA administrated cases only** and are just for reference. Each score is given mechanically weighted according to the roles of arbitrators in a case. The score in black means the total points given weighted according to the roles of arbitrators: 1 point for a party-appointed arbitrator, 2 points for a sole arbitrator and 3 points for a third arbitrator. The score in orange includes the total points given weighted according to the role of mediators in a case: 1 point for a sole mediator or a co-mediator, and 2 points for a third mediator. With respect of those who have ever played both roles of arbitrators and mediators, the score in orange includes the score calculated in the above paragraph on the score in black.
