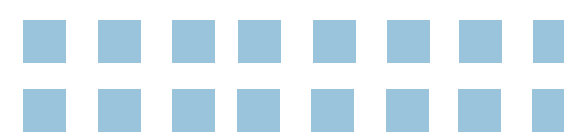


# JOINT WEBINAR

## MEET OUR SPEAKERS AND PANELISTS



**Tony Andriotis**  
Partner at DLA PIPER

Tony Andriotis is a Partner at DLA PIPER, where he leads the firm's international arbitration team in Tokyo. He has served as a representative from Japan for the United Nations Commission for International Trade Law (UNCITRAL) since 2000. He also served as a representative from Japan for the Hague Conference on Private International Law. Additionally, he has served as a member of many advisory committees for the Japanese Government, including the Ministry of Justice, Ministry of Foreign Affairs and Ministry of Economy, Trade & Industry. Yoshihisa also serves as a Vice-Chairperson of the International Committee of Tokyo Bar Association.

**Giorgio F. Colombo**  
Professor of Law at  
Nagoya University

Giorgio Fabio Colombo is a Professor of Law at the Graduate School of Law of Nagoya University, where he is in charge of Comparative Private Law and International Commercial Arbitration, and is the Director of the Research Unit on “Decolonizing Arbitration”. He is also an International Adjunct Faculty Member at the Uppsala University Master’s Program in Investment Arbitration. Prior to these, Giorgio was an advisor to the Judicial Academy of the Islamic Republic of Pakistan in arbitration training classes. He was also a Visiting Researcher at Ritsumeikan University (Kyoto), Adjunct (and then Visiting) Professor of Japanese Law (“Ca’ Foscari” University of Venice, Italy), and Research fellow of the Italian School of East Asian Studies (ISEAS).

Outside academia, Giorgio is admitted to the Bar of Milan (Italy) and has extensive experience as an arbitrator, administrative secretary, and counsel in arbitration procedures. He is listed as a candidate arbitrator with EDCA, Japan Commercial Arbitration Association (JCAA), and Thai Arbitration Institution (TAI).



**Johnny Tan Cheng Hye**  
Independent Arbitrator

Johnny Tan Cheng Hye is a Founding Partner of LT&T Architects where he practised for over 30 years. At present, Johnny practises as an independent arbitrator, adjudicator, and mediator. He is a former President of the Singapore Institute of Arbitrators (SIArb), where he served for two terms from 2007 to 2011. He is also a member of the Singapore Infrastructure Dispute-Management Protocol Advisory Panel.
