### Synopsis

Parties to arbitration agreements refer their disputes to arbitrators with a range of expectations as to arbitrator behaviour. Often, these expectations are formed without much consideration of the arbitrator’s precise legal status. Assumptions range from arbitrators having a contractual relationship with one or both parties or with an arbitral institution, to arbitrators having a status conferred by law and convention. Some regard arbitrators to be private judges while others regard them to be facilitators of settlement of the dispute. Missed expectations sometimes arise as to arbitrators’ responsibilities in relation to application of the law, delegation of work and articulation of parties’ cases.

What is the role of an arbitrator when he or she is appointed by a party, by an institution or by fellow arbitrators and what goes on behind closed doors when a tribunal deliberates?

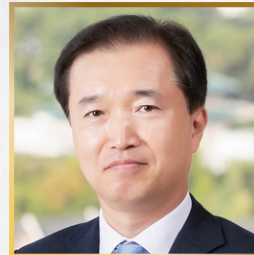
